LIMITED RIGHT-TO-USE SOFTWARE LICENSE AGREEMENT

NOTICE: READ THE TERMS AND CONDITIONS OF THIS AGREEMENT BEFORE YOU INSTALL OR USE THE

SOFTWARE. BY INSTALLING OR USING THE SOFTWARE YOU SHOW YOUR ACCEPTANCE OF THE TERMS OF

THIS LIMITED RIGHT-TO-USE SOFTWARE LICENSE AGREEMENT.

ALL TERMS AND CONDITIONS CONTAINED WITHIN THE AGREEMENT ARE IN EFFECT UNTIL YOU DESTROY

THE SOFTWARE AND ANY AND ALL ASSOCIATED LICENSE KEYS.

LIMITED RIGHT-TO-USE SOFTWARE LICENSE AGREEMENT

The terms and conditions of this Agreement will apply to the software and derivatives obtained there from, including any copy ("SOFTWARE"). The term SOFTWARE includes programs and related documentation provided.

1. TITLE AND LICENSE GRANT

The software is copyrighted and/or contains proprietary information protected by law. All SOFTWARE, and all copies thereof, are and will remain the sole property of Unitrends Corporation (Unitrends) or Unitrends suppliers. Subject to the payment of fees specified in an accepted purchase order or authorization for one or more license keys, Unitrends hereby grants to you, for the period of time specified in such order or authorization, a limited, personal, nontransferable and non-exclusive right to use the SOFTWARE, in accordance with all United States domestic and import laws, on only that computer, server or authorized clients and only for up to the maximum number of clients specified in such order or authorization. Any other use of this SOFTWARE is inconsistent with the terms and conditions of this Agreement, including without limitation, transfer of the SOFTWARE to another computer or to another party, shall automatically terminate this license.

You agree to use your best efforts to see that any use of the SOFTWARE licensed hereunder complies with the terms and conditions of this License Agreement as well as all laws and regulations of the United States and any foreign country in which the SOFTWARE is used. You further agree to refrain from taking any steps, such as reverse engineering, reverse assembly or reverse compilation, to derive a source code equivalent of the SOFTWARE.

2. SOFTWARE USE

A. You are permitted to make a single archive copy of the SOFTWARE, provided the SOFTWARE shall not be otherwise reproduced except as is necessarily incident to the execution of the SOFTWARE in a computer, server, or Data Protection Unit (DPU) or Data Protection Vault (DPV). Any such copy shall contain the same copyright notice and proprietary marking appearing on the original SOFTWARE. The SOFTWARE shall not be disclosed to others in whole or in part.

B. The SOFTWARE and any and all associated license keys,

1. together with any archive copy thereof, shall be either returned to Unitrends or certified as having been destroyed when the SOFTWARE is no longer used in accordance with this License Agreement, or when the right to use the software is terminated; and

2. shall not be removed from a country in which use is licensed or from any computer or server on which it is licensed without Unitrends' express written permission.

3. LIMITED WARRANTY

A. UNITRENDS WARRANTS ONLY THAT THE SOFTWARE WILL BE IN GOOD WORKING ORDER AND, FOR A PERIOD OF THIRTY (30) DAYS FROM THE INITIAL PURCHASE OF THE ASSOCIATED LICENSE KEY(S), WILL REPLACE, WITHOUT CHARGE, ANY SOFTWARE WHICH IS NOT IN GOOD WORKING ORDER.

B. UNITRENDS DOES NOT WARRANT THAT THE FUNCTIONS OF THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT SOFTWARE OPERATION WILL BE ERROR-FREE OR UNINTERRUPTED.

C. UNITRENDS HAS USED REASONABLE EFFORTS TO MINIMIZE DEFECTS OR ERRORS IN THE SOFTWARE. HOWEVER, YOU ASSUME THE RISK OF ANY AND ALL LIABILITY, DAMAGE OR LOSS FROM USE, OR INABILITY TO USE THE SOFTWARE.

D. YOU UNDERSTAND THAT, EXCEPT FOR THE 30 DAY LIMITED WARRANTY RECITED ABOVE, UNITRENDS, ITS AFFILIATES, CONTRACTORS, SUPPLIERS AND AGENTS MAKE NO WARRANTIES, EXPRESS OR IMPLIED, AND SPECIFICALLY DISCLAIM ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR WARRANTY AGAINST INFRINGEMENT.

E. UNITRENDS DOES NOT GUARANTEE THAT PROBLEMS WILL BE SOLVED OR THAT ANY ITEM WILL BE ERROR-FREE. THIS AGREEMENT IS ONLY APPLICABLE TO UNITRENDS SOFTWARE RUNNING UNDER THE CERTIFIED ENVIRONMENTS SPECIFIED IN THE RELEASE NOTES FOR THAT PRODUCT. UNITRENDS MAY FROM TIME TO TIME, DISCONTINUE SOFTWARE PRODUCTS OR VERSIONS AND STOP SUPPORTING SOFTWARE PRODUCTS OR VERSIONS ONE YEAR AFTER DISCONTINUANCE, OR OTHERWISE DISCONTINUE ANY SUPPORT SERVICE.

4. EXCLUSIVE REMEDIES AND LIMITATIONS OF LIABILITIES

A. YOU AGREE THAT YOUR SOLE AND EXCLUSIVE REMEDY AGAINST UNITRENDS, ITS AFFILIATES, CONTRACTORS, SUPPLIERS, AND AGENTS FOR LIABILITY, LOSS OR DAMAGE CAUSED IN ANY WAY BY THE SOFTWARE REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT, TORT, INCLUDING NEGLIGENCE, STRICT LIABILITY OR OTHERWISE, SHALL BE THE REPLACEMENT OF UNITRENDS FURNISHED SOFTWARE WITHIN THE LIMITED WARRANTY PERIOD. THIS SHALL BE EXCLUSIVE OF ALL OTHER REMEDIES AGAINST UNITRENDS, ITS AFFILIATES, CONTRACTORS, SUPPLIERS OR AGENTS, EXCEPT FOR YOUR RIGHT TO CLAIM DAMAGES FOR BODILY INJURY TO ANY PERSON.

B. REGARDLESS OF ANY OTHER PROVISIONS OF THIS AGREEMENT, NEITHER UNITRENDS NOR ITS AFFILIATES, CONTRACTORS, SUPPLIERS OR AGENTS SHALL BE LIABLE FOR ANY INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES (INCLUDING LOST PROFITS) SUSTAINED OR INCURRED IN CONNECTION WITH THE USE, OPERATION, OR INABILITY TO USE THE SOFTWARE.

C. YOU AGREE THAT IN THE EVENT ANY CLAIM, SUIT OR PROCEEDING IS BROUGHT AGAINST UNITRENDS IN CONNECTION WITH THE SOFTWARE OR THIS AGREEMENT, SUCH CLAIM, SUIT OR PROCEEDING WILL BE BROUGHT OR FILED IN THE COURTS OF THE STATE OF SOUTH CAROLINA, UNITED STATES OF AMERICA, AND THAT ANY SUCH CLAIM, SUIT OR PROCEEDING WILL BE GOVERNED BY THE LAWS OF THE STATE OF SOUTH CAROLINA, UNITED STATES OF AMERICA, WITHOUT REGARD TO ITS CHOICE OF LAW RULES.

D. UNITRENDS IS NOT LIABLE FOR INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES FOR ANY REASON (INCLUDING LOSS OF DATA OR OTHER BUSINESS OR PROPERTY DAMAGE), EVEN IF FORESEEABLE OR IF CUSTOMER HAS ADVISED OF SUCH A CLAIM. UNITRENDS'S LIABILITY SHALL NOT EXCEED THE FEES THAT CUSTOMER HAS PAID UNDER THIS AGREEMENT.
